Innovating Operations

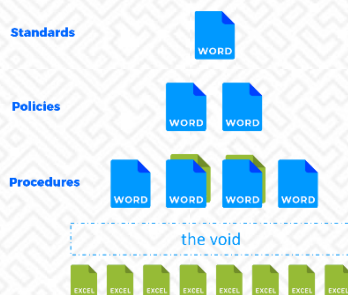
At CoVi Analytics, innovation is not just a buzzword; it's at the heart of everything we do to help businesses achieve operational efficiencies.

Here are some of the ways in which we are redefining the status quo.

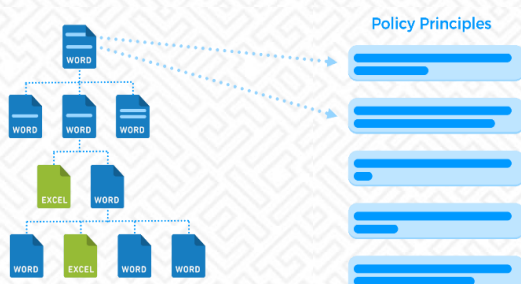
Business Policies

Typically, regulated firms guide their teams using a large document suite consisting of policies, standards, and procedures. Keeping these documents updated requires significant effort, but this effort doesn't necessarily help the business operate more effectively.



Our approach relies on identifying the key outcomes the business is attempting to achieve, commonly referred to as Policy Principles by many practitioners.

Policy 2.0 App allows policies to be restructured into a collection of these specific policy principles, removing a lot of unnecessary words from the usual policy documents, improving engagement level and reducing update effort.



CORE Elements

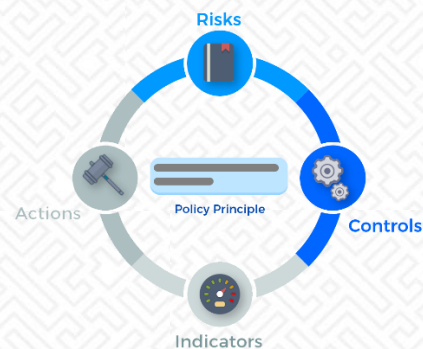
Measuring and monitoring operational activities against the requirements set out in business policies is often delivered through an abstract framework designed by the second-line teams who are a step removed from the operational day-to-day.

While being great in theory, these frameworks are hard to integrate with the operational realities. This leads to extra work for the front-line teams as they have to manage information requests from R&C or Audit teams alongside delivering their regular tasks.



Our approach builds on the Policy Principles by letting the owner of the policy principle define:

- What could go wrong if the principle is not delivered (**Risks**);
- What business activities will be performed to ensure the Principle outcome is delivered (**Controls**);
- What monitoring can be performed to ensure the team is on track (**Indicators**); and
- What action (if any) do we need to take when things don't go to plan (**Actions**)
